

Welcome to the Lion Medical Research Personality Quest and to becoming an Entrant.

The Quest began in 1969/1970 as the Lions Miss Personality Quest with the Focus to raise funds for the Lions Medical Research Foundation to continue its aim to fund medical researchers.

The money raised over these years has greatly contributed to the remarkable escalation of better treatments and prevention of diseases.

## Conditions of Entry

The Quest is open to females who have reached the age of 18 years by nomination.

The decision to accept or refuse any application for entry is at the discretion of the Quest Committee. The Committee is not obliged to provide any written or verbal reasons for its decisions.

The Official Entry Form must be used for applications to enter the Quest and be accompanied by the entry fee of \$110 (one hundred and ten dollars) for entrants.

A minimum fundraising amount of \$1000.00 (one thousand dollars) in addition to the entry fee of \$110.00 (one hundred and ten dollars), must be deposited by an entrant, or her sponsor by 31st March with the Quest office for the entrant to be eligible for the Quest.

The entrant who wins the title of "Personality" winner and "Charity" winner will be expected to participate in Quest promotions during the ensuing Quest year. They must also make themselves available, if requested, to attend Preliminary and Grand Final Quest judgments during the year following their selection.

Each eligible entrant shall be judged at an official Preliminary Final and Grand Final on dates and venues to be advised by the Quest Committee. They shall wear appropriate day and evening wear. At all Quest Judgings, the Judges' decision will be final with no further discussion or correspondence entered into.

Entrants agree not to make any claims on the Quest, it's organisers, Lions Clubs International or any member thereof for expenses incurred whilst an entrant in the Lions Medical Research Personality Quest except for travel and accommodation costs outlined in the relevant sections of the Quest Handbook.

Insurance coverage through Lions International is available to cover accident insurance requirements for each entrant.

At the Grand Final, one entrant shall be selected as "Personality" winner and the entrant who raises the most money is announced as the "Highest Charity Fundraiser". Should this be the same person, then she shall receive the prizes for both sections.

The Quest Committee shall have the right, at any time, to vary the nature and/or number of gifts and the conditions under which the gifts shall be awarded.

Subject to the privacy policy of the Lions Medical Research Foundation, the entrant's personal information required to complete the official Entry Form is for the use of the Quest only and will not be provided to any third party. The information will only be used to maintain the relationship between the Quest and entrants throughout the period of the Quest.

By completing and signing the Official Entry Form, entrants also agree that the Quest may use any photographs of entrants taken throughout the Quest for advertising and promotional purposes.
